EXECUTIVE SUMMARY

This report evaluates some of the successes of the activation as well as opportunities for improvement, some of the key successes and improvement opportunities are:

Key Successes

We activate the Severe Weather Guidance for unusually cold temperatures, which posed a risk to the public for several days. Successes included coordination calls and coordination of logistical supplies for the efficient operation of warming centers.

One of the biggest challenges we had to overcome with warming centers is getting people to access the centers. Many people do not want to leave their place of residence due to worry of theft, no means of transportation, don't want to leave their pet alone, etc. Two successes we had this past winter were:

Pets: Increased acceptance of pets in warming centers through the use of kennels provided by County Animal Control.

Transportation: Coordinating with Sacramento Regional Transit (SacRT) to provide bus rides to, from, and between warming centers through the use of strategically located bus stops along a dedicated route.

Key Improvement Areas

Reduce fatalities: Continue working in collaboration with Public Health Public Information Officers and local advocates of people experiencing homelessness to get information distributed regarding warming center hours and location, transportation options, and signing up to receive Sacramento Emergency Alerts (SacAlert).

Pets: Although this past season was an improvement from past years, more work is needed to identify pet-friendly locations, provide additional kennels and/or convince non pet-friendly locations to reconsider.

Administration: Because staff do not always work for the same agency or location throughout the season, we need to improve the standardization of documentation (rosters, sign-in, registration, tallies, etc.) throughout facilities. Update Field Operating Guide and ensure synergy with new Extreme Cold and Freeze Hazard Annex and distribute.

KEY CHRONOLOGICAL EVENTS

December 16, 2021

Held severe weather coordination call with stakeholders (36 participants). NWS published a Wind Advisory from 10am on the 15th to 2am on the 16th. Seven warming centers were opened between December 17th and 20th.

December 29, 2021

Held severe weather coordination call with stakeholders (4 participants). The NWS published a Hard Freeze Watch valid from 27-30 December. A Wind Advisory was also published valid from 4am to 10pm on Monday, December 31, 2021 for gusts up to 45-50 mph. Regional Transit route schedule for the weekend of December 31, 2021 to January 2, 2022. This is a dedicated shuttle route to transport passengers to available warming centers. Six warming centers were opened between December 31, 2021 and January 3, 2022

February 1, 2022

Held severe weather coordination call with stakeholders (31 participants). NWS published a Wind Advisory from 1030am on the 1st through 2am on the 3rd.

February 18, 2022

Held severe weather coordination call with stakeholders (23 participants).

February 22, 2022

Held severe weather coordination call with stakeholders (36 participants). NWS published a Freeze Watch, then Freeze Warning, valid from 2am on the 22nd, through 9am on the 25th. Five warming centers were opened between February 22nd and 26th.

At the time of publication, the County Coroner has determined that the following deaths during the winter of 2021/2022 were cold related. The Coroner may verify additional deaths later and remains the official source of death reporting for Sacramento County.

October – December 2021 Confirmed Cases

Case	Date	Description
21-07211	10/23/2021	This decedent was a 92 year old female that fell in her home and was lying on her floor for an extended period of time. She was not outside, but her death is due to hypothermia from lying on a cold floor. This occurred in the City of Sacramento sometime between 10/23 and 10/28. Cause will be hypothermia.
21-07152	10/25/2021	This decedent was an 80 year old female found partially clothed in her backyard on 10/25/2021 and wet. Unknown why she was in her backyard and not inside. Cause of death Hypothermia.
21-07627	11/16/2021	This decedent was a 67 year old male that was not transient. He was pulled over in this vehicle on Hood Franklin Rd where he was found. He reportedly was traveling to see his son in Washington. He lived in Stanislaus County. He was also using methamphetamine which is likely why he was susceptible to the cold. Cause is Hypothermia with an OSC of Methamphetamine use.
21-08286	12/15/2021	This decedent was a 57 year old male that was found near the 11 St and Q St in the City of Sacramento. He had significant medical history and history of drug use. He died in the ER at Sutter, but was reported as being cold and wet when found. Cause will be hypothermia.
21-08348	12/18/2021	This decedent was a 62 year old transient male that was found at a bus stop at 28 th and L Street on 12/18/2021. He was taken to Sutter. His body temp was very low. Cause will be hypothermia.
21-08440	12/22/2021	This decedent was a 61 year old male transient that was camping out along the American River north of Camp Polluck. He was last seen alive on 12/21 acting erratic. He was found deceased on 12/22/2021 almost 24 hours of last being seen. Cause: Hypothermia.

STRENGTHS

Mass Care & Shelter Coordination

The OES Mass Care & Shelter Coordinator in coordination with county partners were able to identify, establish and support the operation of fourteen (14) warming centers within the community.

Strength 1.1: Coordination between OES, other county departments, cities, and volunteers. Conducted daily weather calls to ensure everyone had accurate information on the weather conditions and activation status according to the plan and identify activities each agency was engaging.

Transportation

Regional transit provided two transportation routes from encampments to warming centers. This fixed route service operated during the opening hours between 7pm and 11pm and at closing time between 7am and 8:30am. Pickup locations were Stockton & Fruitridge, Ahern & N. C St, Watt & Poplar and Fulton & Alta Arden. Drop off locations were 29th & R and El Camino & Meadowbrook.

Strength 1.2: Coordination with, and responsiveness of, Regional Transit to provide transportation services along a fixed route.

Adherence to Plan

OES followed the procedures outlined in the plan. Weather coordination calls were convened and information distributed to 2-1-1, Public Information Officers and Media.

Strength 2.1: There were 19 social media posts, 21 Earned Media releases, 10 tweets and 8 Facebook posts.

Simultaneous Emergencies

Staff responded to simultaneous emergencies including the utilization of criteria for response to the COVID-19 disease following restrictions in place for warming centers requiring social distancing. All warming centers required the use of masks, which were made available, through Sac OES Logistics, to those organizations wishing to access them.

Strength 3.1: Agencies participating in warming centers observed CDC and CDPH Guidance regarding warming center operation to screen visitors and provide opportunities for social distancing.

AREAS FOR IMPROVEMENT

Reduce Fatalities

Of the six fatalities attributed in some portion to the effects of cold, one had evidence of drug use that contributed to their death.

- Improvement 1.1: Work with Public Health public information officers to share information with advocates to help unhoused individuals understand the risks of drug use and severe weather, and take protective action.
- Improvement 1.2: Work with homelessness advocates to encourage those who are unhoused to register for Sacramento Alert and subscribe to the Severe Weather Cold/Cold list.
- Improvement 1.3 Work with the Department of Child, Family and Adult Services (Senior Adult Services) on educating the elderly population about the risks of severe temperatures and what actions to take to keep safe.

Pets

Although this past season was an improvement, more work is needed in providing resources and accommodations that accept pets.

- Improvement 2.1: Identify more pet-friendly locations, provide additional kennels and convince non pet-friendly locations to reconsider.
- Improvement 2.2: Research equipment options that would make indoor sheltering of pets more feasible or the possibility of equipment to safely shelter pets outdoors.
